# PUBLIC SAFETY SOLUTION

Over the decades of San Francisco Pretrial's work, our outcome data has been top in the field. Now, in a moment of challenging conditions and historically high caseloads, **San Francisco Pretrial's safety outcome data has remained strong, exceeding outcomes in other California pretrial programs as well as established programs around the country.**

As our contract requires, San Francisco Pretrial serves every person the courts refer to us, and we are dedicated to helping our clients overcome numerous structural barriers. We have a hands-on approach where we don't just refer our clients to services, we accompany them—even meet them at their house, hotel, or tent—and ensure they get to their appointments.

San Francisco jails are at their highest capacity since before COVID, and over 75% of people in San Francisco jails struggle with a behavioral health challenge.<sup>1</sup> Research shows that connecting people to behavioral health services reduces their likelihood of reincarceration.<sup>2</sup> **San Francisco Pretrial made 1,500 referrals to therapeutic resources for our clients in the last year, helping to reduce the likelihood of continued system involvement. These referrals include mental health, substance use, and other critical human services.**

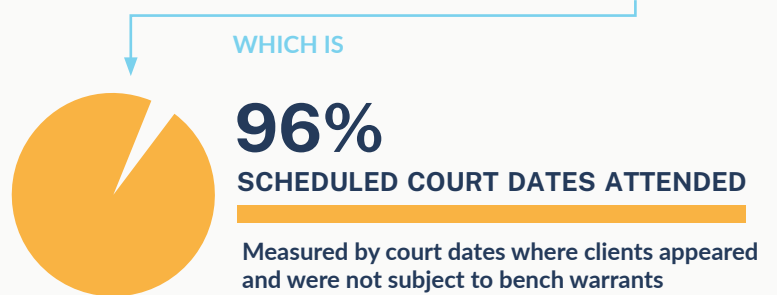
Despite the structural barriers many of our clients are facing, such as deep criminal legal system involvement, housing instability, addiction, and behavioral health issues, we find they are committed to fulfilling their court obligations and, with our support, are able to successfully fulfill—if not exceed—these expectations.

With our support, our clients attended over 19,000 court dates Jan 2023–May 2024, over 96% of all scheduled dates. From July–Dec 2023, 79% of our clients attended their court dates without receiving any bench warrants (appearance rate). While San Francisco Pretrial serves an especially high number of high-risk and high-needs clients for longer periods of time than many other pretrial programs, **our appearance rates exceed pretrial programs in Sonoma County,<sup>4</sup> Santa Clara County,<sup>5</sup> and the average of California pretrial pilot programs.<sup>3</sup>**

In studies done across the country and locally, the most common reasons people miss a court appearance relate to **homelessness and instability, transportation** (affording it, navigating it and coordinating it), and **time off work or childcare duties.**<sup>8</sup> In New York City research shows that 40% of people who miss a court appearance appear voluntarily within 30 days.<sup>9</sup> **San Francisco Pretrial works with our clients to overcome these barriers and ensure our clients get back to court if they do miss a court date.**

**HOMELESSNESS AND INSTABILITY • TRANSPORTATION ISSUES  
TIME OFF WORK • CHILDCARE DUTIES**

A recent study found that “housing was the most significant predictor of missing a court appearance and individuals with unstable housing were twice as likely to miss a court appearance compared to individuals with stable housing.”<sup>10</sup>

## THE IMPORTANCE OF PRETRIAL RELEASE

One in three adults in the U.S. has been arrested.<sup>11</sup> People in pretrial have not yet been convicted of any wrongdoing, yet pretrial detention has lasting and long-term social and financial impacts. Jail conditions are notoriously poor, are traumatic, create vulnerability to abuse, and exacerbate physical and mental health conditions. For the majority of the pretrial population, **detention increases the likelihood of future arrests, limits job and housing prospects, and reduces access to life-saving behavioral health services, adversely impacting public safety.**<sup>12,13</sup>

If held in pretrial detention, people are:

- **MORE ARRESTS:** 9.7% MORE LIKELY to be charged with a new misdemeanor within 18 months<sup>14</sup>
- **LESS EMPLOYMENT:** 12% LESS LIKELY to be employed 3 years after their bail hearing<sup>14</sup>
- **MORE CONVICTIONS:** 14% MORE LIKELY to plead guilty and 18% MORE LIKELY to be convicted<sup>14</sup>

**Studies across the U.S. have found no negative public safety impacts connected to reducing pretrial detention.** For example, a study in Texas shows that when people are released pretrial there is a 32% reduction in new felony charges within 18 months.<sup>14</sup>

# COST-EFFECTIVE AND TRUSTED PARTNER

Embedded in San Francisco for 48 years, San Francisco Pretrial has built over 200 lasting partnerships with community organizations and agencies, from the Superior Court, District Attorney's office and Sheriff's Office to Latino Task Force, HealthRight 360, Larkin Street, and NA/AA.

Our approach is based on trust, relationship-building, and community involvement. **We meet clients where they're at and, if a resource isn't readily available, our staff will go above and beyond to find it to help our client's get back on track.** Many of our staff have lived experience within the communities we serve and the criminal legal system. They care deeply about our clients, our city, and the safety of all of our families and loved ones. With research from Advancing Pretrial Policy and Research Collaborative, we know that hiring people with personal experiences with the criminal legal system is a best practice for pretrial work and improves outcomes.<sup>15,16</sup> We hire strategically, invest deeply, and prioritize training and internal advancement. Our clients reap the benefits of community-connected staffing and long-term staff retention, which has been maintained at the highest level since San Francisco Pretrial's growth spurt.

**By keeping people out of detention and accessing support in community, San Francisco Pretrial reduces jail overpopulation which, in turn, increases safety for incarcerated populations and reduces strain on city budgets.** Through partnership with San Francisco Pretrial, San Francisco is showing the country another way forward to meet the needs of our community members and enhance long-term public safety.

It is costly to incarcerate people. It costs an estimated \$250 per day to incarcerate an individual in San Francisco city and county jails<sup>17</sup> and, in 2023 San Francisco Pretrial saved San Francisco 630,394 days of unnecessary and costly confinement.

Despite our comprehensive approach, San Francisco Pretrial remains relatively lower cost compared to other agencies operating community supervision and reentry programs:



In addition to our city funding, San Francisco Pretrial has secured over \$8 million over the past three years in additional foundation, individual, state, and federal funds ensuring long-term fiscal sustainability and allowing us to offer enhanced and diversified services.
